Indemnity And Rules:

1. I hereby acknowledge that my, that of my family and friends use of the "Nature Valley" is potentially dangerous and that I, my family and friends make use of the "Nature Valley Area" entirely at our own risk. I undertake to take whatever precautions are necessary to ensure that I, my family and friends utilise the "Waterkloof Ridge Nature Valley" in a safe manner. Accordingly, I, my family and friends utilise the "Nature Valley" entirely at our own risk and indemnify and hold harmless, Waterkloof Ridge Nature Valley NPC as well as Waterkloof Boulevard Home Owners Association NPC, their successors in title or assigns, as well as all Directors, Employees, Contractors, Shareholders and Agents, related to or associated with either and or both Companies, from time to time, from all claims, howsoever arising, and shall in no manner whatsoever seek to hold any of them liable, whether due to any act, loss or damage, theft, injury, consequential losses, illness or death, omission or negligence on the part of myself, my family members, friends and visitors entering the "Waterkloof Ridge Nature Valley". I note that this is private property and right of admission is reserved by the Board of Directors of the said Waterkloof Ridge Nature Valley NPC.
2. I acknowledge that the "Waterkloof Ridge Nature Valley" has other users in the form of persons and families and I accept that it is my, my family, friends and visitors responsibility not to cause any disturbance or damage of any kind and to ensure absolute safety at all times. Any damages caused will be for my own account.
3. I agree to brief any of my family members and/or visitors regarding the indemnity and rules and will only allow a person into the "Waterkloof Ridge Nature Valley Area" after full acknowledgement of this indemnity and rules.
4. No disturbance or removal of any fauna or flora inside the "Waterkloof Ridge Nature Valley" is allowed.
5. No firearms or alcohol are allowed inside the "Waterkloof Ridge Nature Valley".
6. Pets may enter the park, only when they are kept on a leash and must be controlled in a way as not to interfere with any birds, wildlife or pedestrians.
7. Owners of the pets are responsible for removing any excrement deposited by their pets when inside of the "Waterkloof Ridge Nature Valley".
8. Children under the age of 18 must be under the supervision of an adult at all times.
9. No feeding of animals are allowed.
10. No firewood may be collected from the "Waterkloof Ridge Nature Valley" and no open fires inside the "Waterkloof Ridge Nature Valley" are allowed.
11. No Dumping allowed inside the "Waterkloof Ridge Nature Valley". (Garden Refuse, Building Rubble, Animal Faeces, etc).
12. No fireworks may be set off inside the "Waterkloof Ridge Nature Valley".
13. No excessive noise e.g. audio systems, fireworks, etc.
14. No motorised vehicles allowed.
15. Please be aware that all the fences are open electrified fences. Please do not touch the fences and please keep children clear from the servitude fences.
16. Beware of snakes, spiders, slippery path ways, loose rocks, holes in the ground and bridge crossing.
17. Gates will be opened at 06:00 and will be closed at 18:00.
